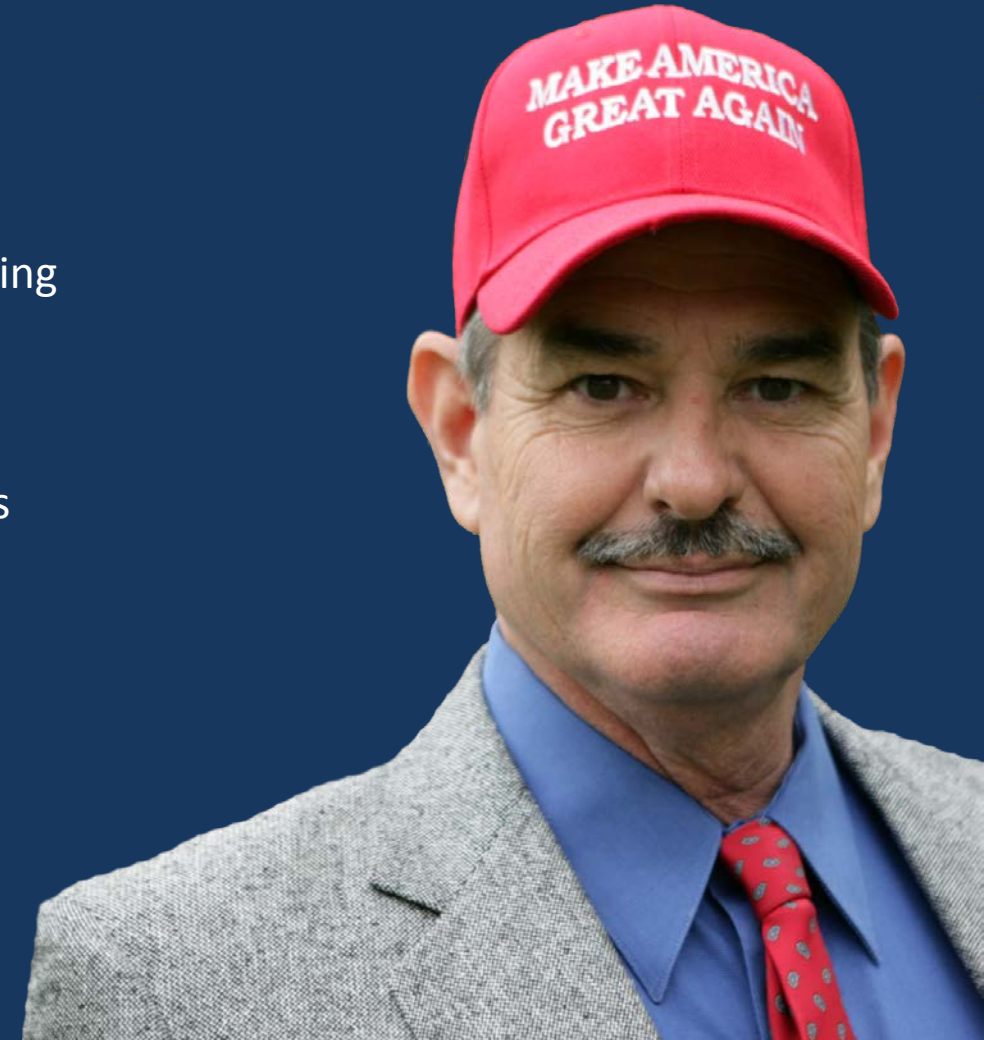

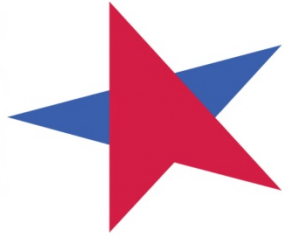

Federal law requires us to use our best efforts to collect and report the name, address, occupation, and employer of individuals whose contribution exceeds \$200 or more in any of the two election cycles.

- 1) You are an American Citizen or lawfully admitted permanent resident.
- 2) Contribution must be made from your personal funds and not from an account maintained by a corporation, labor union, national bank and you must not be reimbursed by another person or entity for your personal donation.
- 3) You are not a federal government contractor.

NOTE: The maximum amount an individual may contribute is \$2,800 per election. Your contribution (up to \$2,800) will be designated for the primary election. You can donate a 2nd time (up to \$2,800) that can be designated for the general election, for a total of \$5,600. Contributions to Earl Lackie For Congress are not tax deductible for federal income tax purposes. Contributions from corporations, labor unions, federal contractors, and foreign nationals are prohibited.
